## ILC Registration

The ILC Registration deadline is 5-15-2023. Register through you chapter log in. Scroll down to Conferences and then click on the 2023 ILC card.

Registration fee for NVHOSA is \$125.00. This registers them for their competitions. They may also choose **ONE** free Cengage ATC test as part of that registration. Additional tests may be taken for \$20.00 each. The one free one will show as \$20.00 but will come off after you save that registration. They will also receive 5 trading pins and a spirit item.

The substitution policy for the ILC is as follow: 25% of the original team must be registered for the event.

Each attendee will need to complete an ILC Code of Conduct and a Medical Liability Form.
